Illinois Relay Service - Dial 7-1-1



What is the Illinois Relay?

Illinois Relay is a free, completely confidential 24-hour public service that makes the use of the telephone possible and a better experience for many thousands of citizens and visitors of the state who are deaf, hard of hearing,

deaf/blind, speech-disabled, and hearing.

How does Illinois Relay work?

Simply dial 711 or the appropriate toll-free number provided to connect with Illinois Relay. A qualified Communication Assistant (CA) will ask for the area code and number of the person you wish to call and begin the relay call. Generally, the CA will voice the typed message from the text telephone (TTY) user to you. The CA relays your voiced message by typing it to the TTY user.

Specialized Services:

Illinois Relay offers specialized services for individuals who have difficulty speaking and for Spanish speaking residents. Specially trained CAs are on hand to assist in these types of calls by dialing the associated number provided. Since Illinois Relay offers a variety of services please refer to the website listed or call Illinois Relay Customer Care for more detailed instruction on how a particular call is processed.

Captioned Telephone Service (CapTel®):

CapTel® is also available and ideal for individuals with hearing loss who are able to speak for themselves. A captioned telephone works like any other telephone with an essential difference: it allows users to listen to their phone conversations while reading word-for-word captions of what's said to them.

Access to Services:

Both 711 and the 800 numbers are toll-free calls and provide access to the same relay services. If you are experiencing trouble dialing 711 to reach Illinois Relay, please call Illinois Relay Customer Care.

All services are available 24 hours a day, seven days a week. Consumers may place relay calls to English and Spanish speaking persons within Illinois, across the United States and even internationally. By law, each conversation is handled with strict confidentiality. There is no charge to access Illinois Relay.

TRS is supported by surcharge: A few cents per telephone bill surcharge makes Illinois Relay services possible for the citizens of Illinois. Currently, Sprint is the provider of the relay services for Illinois.

Special points of Interest:

Illinois Telecommunications Access Corporation (ITAC)

Illinois law requires all landline, cellular phone companies, and most Cable and VoIP phone companies to provide telephone access for people who are Hard of Hearing, Late Deafened, Deaf, Deaf-Blind or Speech Disabled. ITAC is the not-for-profit corporation established to provide a Free Equipment Program and Illinois Relay on behalf of these phone companies. Emergency Calls

Please note that 711 is only to be used to reach Illinois Relay. In an EMERGENCY you should continue to use 911. For emergencies, call or text 911 (where available) or call your local emergency service TTY number directly, without using relay. The Americans with Disabilities Act (ADA) requires that 911 centers have a TTY and be prepared to handle emergency calls placed in this manner. Illinois Relay will make every effort to assist you in an emergency. However, it is important to understand that relay centers are not 911 centers and do not assume responsibility for emergency calls.

When Your Phone Doesn't Work

When your phone doesn't work, you can avoid having to pay for an unnecessary service call by checking your phone yourself. Try these simple tests to determine if the problem is in your phone or in our phone lines. If the problem occurs in our phone lines, please call 1.844.968.7224. For TTY users (hearing impaired), call 1.800.838.7611.

For Modular Phones

Unplug the phone from the outlet where you noticed the problem. Plug in another phone you know is working properly. If the trouble disappears, the problem was probably in your phone. For complete information about disconnecting your phone, see pages 4-5.

If the problem continues, there may be a problem with the phone lines. Consolidated Communications will repair the outside phone lines for free. In addition, we offer maintenance plans for the phones and wiring inside the home or business.

For Non-Modular Phones

Try another phone on the same line to see if the problem persists. If it continues, your phone lines may need service.

Maintenance Plan

Consolidated Communications offers your residence and business a maintenance program for phones, jacks and wiring.

WireCare maintenance is offered to all residential and single-line business customers for a monthly charge. WireCare covers only the repair and/or replacement of existing jacks and telephone wiring inside the customer's home or business. Telephones are NOT covered under this plan.

If a service call is made to a home or business and Consolidated Communications finds that the problem is in the customer's telephone, the customer will be charged for the service call. The customer will be billed at quarter-hour increments, plus a service call charge for residential and business customers. Call customer service at 1.844.968.7224 to obtain current labor charges.

What WireCare Covers:

- All service calls
- Routine testing and diagnostic work
- Repair or replacement of standard inside wiring with like wiring
- Repair or replacement of existing jack
- If you pay off-premise mileage to an unattached structure at a different location, your WireCare plan also covers inside wiring at that location

What Is Not Covered By WireCare:

- Fire and acts of God (lightning, floods, etc.)
- Improperly installed or non-standard wiring
- Repair or replacement of telephones
- Inside wiring in an unattached structure (customer is not paying off-premise mileage)

The minimum contract period is 12 months.

Service Connection Charges

There will be a one-time charge to cover processing your order and connecting you to our network. Your Consolidated Communications Customer Service Representative can tell you exactly which rates will apply. A good payment record for previous phone service usually is enough to establish your credit. But, if you haven't had service before, other credit references will be necessary. Your Consolidated Communications Customer Service Representative can answer credit questions and let you know if a deposit is necessary and the amount required.

Digging/Drilling - Call 811

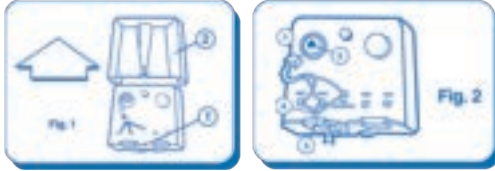
Before you dig call J.U.L.I.E. (Joint Utility Locating Information for Excavators-available 24 hrs. The Illinois Underground Facilities Damage Prevention Act requires every person who engages in non-emergency excavation or demolition to learn about possible location of underground utility facilities and to notify the state-wide one-call notice system (JULIE) between 48 hours for excavation and 14 days for demolition. The law carries fines for persons cutting underground cables.)

Connecting Inside Wiring

Connecting Your Inside Wire To A Network Interface Device

The Network Interface Device (NID) enables customers to connect their own inside telephone wiring with the telephone company's network. There are a number of different types of NIDs that Consolidated Communications currently uses, including a 1-2 line unit and a 1-6 line unit.

To connect your inside wiring to the NID, follow the steps that apply to the unit on your building.



1-2 Line Unit

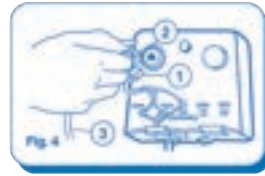
1. (See Fig. 1) Open the unit by loosening the screw at the bottom of the NID.
2. Lift the outer cover straight up over the grommet at the bottom of the NID.
3. (See Fig. 2) Disconnect inside wiring modular plug from jack. Your inside wiring ends with separate wires, as shown. Each wire is in a different color: red, green, black and yellow.
4. Insert inside wiring through the rubber grommet at the bottom of the unit. Push any extra wire length back into the building.
5. Connect inside wires to screw terminals. Loosen the screw posts one full turn. Strip off one-half inch of insulation from each wire and connect them to the color corresponding screw post, wrapping each clockwise between the washers on the screw. In some cases, you may not have a black or a yellow wire. If a black wire is present, do not use. Bend the black wire out of the way.
6. Close the unit. Slide the outer cover all the way down over the top of the unit.
7. Tighten the screw at the bottom of the unit.



1-6 Line Unit

1. (See Fig. 3) Unscrew the Network Interface cover at the Customer Access point and open.
2. Disconnect the modular plug from test jack. If you have Internet and/or TV service from Consolidated, disconnect only the modular plug with the VOICE label. This disconnects your inside wiring from the phone company's line.

3. Using a pen or pencil, punch a hole through the grommet and pass the wire through the hole in the grommet (punch one hole for each wire). Pass the wire through the hinge pin.
4. Loosen the screw posts on the customer wiring bridge one full turn. Strip off the one-half inch of insulation from each wire and connect them to the color corresponding screw post, wrapping each clockwise between the washers on the screw. Tuck excess wire in wiring trough. Tighten screws securely.
5. Snap modular plug back into test jack. Close the cover and screw the fastener down until the cover is snug and tight.



How To Test Your Inside Wiring With Network Interface Device

(See Fig 4).

1. Disconnect the inside wiring modular plug from the jack (see instructions above). If you have more than one line, select the test jack for the line that is causing the problem.
2. Connect the modular plug of a working telephone directly to the jack. If you have Internet and/or TV service from Consolidated, be sure to connect your phone to the test jack labeled VOICE.
3. If the telephone operates correctly, the trouble is in the inside wiring. If the telephone does not act/work properly, contact Consolidated Communications repair service toll-free at 1.888.800.1611.



How To Connect Your Phones

The illustrations above should be helpful to you when installing or disconnecting your telephones. Illustrations 1 through 4 show wall receptacles (standard jacks), which can accommodate modular telephone cords. To install your phone, match the plug at the end of the telephone cord with the receptacle and insert. To disconnect the phone, squeeze the clip on the plug and pull out of the receptacle.

Connecting Inside Wiring

Illustrations 5 and 6 show receptacles (non-standard jacks) that can be made to accommodate modular telephone cords by using adapters. The adapters simply plug into the receptacle. With the adapter in place, follow the above steps to install your phone.

A receptacle for a wall-mounted telephone is shown in illustration 7 on page 4. To connect your wall phone, match the holes in the back of the telephone with the rivets on the wall mounting, push the telephone lightly against the mounting while sliding it down into place over the rivets. To disconnect, slide the telephone up to lift it off the rivets, then pull the phone away from the receptacle. Types of modular jacks other than those shown in illustrations may be encountered.

Removing your wall phone

Note: These instructions apply only when you are replacing an existing non-modular wall telephone with a new modular wall telephone.

Tools needed: Screwdriver and wire cutters with insulated grips.

Instructions:

1. Caution: Your telephone may have varying amounts of electricity in the wires and screws. Therefore, to avoid the possibility of electrical shock, follow these instructions:

If you have a telephone at a location other than the one you are converting, take the handset off the hook. (This will keep the phone from ringing and reduce the possibility of contacting electricity. While you're doing this, ignore messages coming from the handset that ask you to hang up the phone.) If you have only one telephone, take the handset of that telephone off the hook.

- Avoid hand contact with bare wires or screws.
 - Use tools with insulated handles or use rubber gloves.
 - Do not install this device while a thunderstorm is in the vicinity.
2. Determine if your telephone is already modular. It is if any of the following conditions exist:
 - Both ends of the handset cord can be unplugged.
 - The telephone is mounted on a 3" X 4 1/2" stainless steel plate.

- It can be removed by lifting it up and pulling it out. If your telephone is not modular, follow the instructions below that apply to the wall telephones shown in figures 1-4.

Note: The remaining illustrations apply to a typical phone. Your specific phone may have a slightly different location for number card retainers, telephone wire entry points, screw lugs and mounting screws.

For traditional wall telephone (rotary), see figure 1.

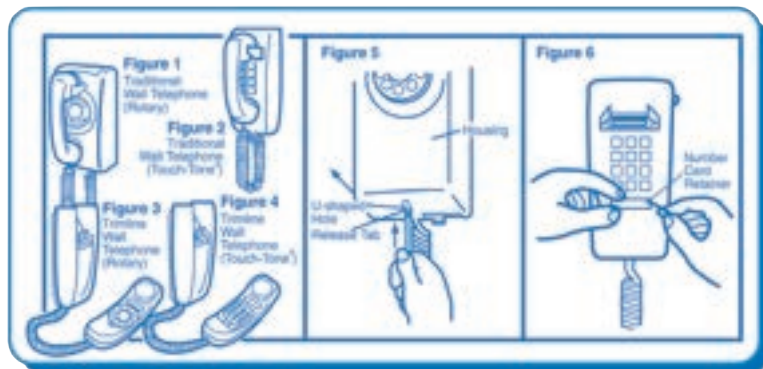
3. Locate the U-shaped hole in the bottom of the wall set (where the handset cord enters the wall set - see figure 5).
4. Place a blunt object (such as a pencil eraser) against the release tab found in the U-shaped hole (see figure 5).
5. To release the housing, press in on the bottom of the housing while pressing up with the pencil on the release tab.
6. Pull the housing toward you, unhooking the latch from the spring at the top of the phone. Now go to step 11.

For phones shown in figures 2, 3, & 4, proceed with Step 7.

7. Locate the small hole on the inside of the clear plastic number card retainer (see figure 6).
8. Insert a straightened paper clip into the hole and bend outward, causing the plastic to pop out.
9. Remove the number card, exposing two screws.
10. Remove these two screws and lift the housing off the base.

For all wall telephones:

11. Locate the telephone wire(s) entering your phone. You may have to remove the phone from the wall to locate the wire(s). If necessary, follow step 13.
12. With wire cutters, cut the four colored conductors (red, green, yellow and black) coming from the wire(s) found above, at the screw lugs (see illustration 7 on page 4).
13. Remove the two screws holding the telephone to the wall and remove the phone.

How to dial local calls:

Within your Local Calling Area (LCA) and same Area Code: Dial Area Code + the 7 digit number (10-digit dialing).
Within your (LCA) but in a different Area Code: Dial 1 + Area Code + 7 digit number OR use 10-digit dialing. Long distance calls remained the same.

Long Distance calls: Dial 1 + area code + 7-digit number whenever placing a long distance call from any area code.

Exchange codes are subject to change. Make sure you know whether a number is local or long distance before you dial. You are responsible for long distance charges.

Area Code Overlay 217/447

The 447 area code was added as an overlay to the region currently served by area code 217 to ensure a continuing supply of telephone numbers for the area. An overlay is the addition of another area code (447) to the same geographic region served by an existing area code (217).

All local calls made within the Illinois 217/447 Area Codes must be placed using the 10-digit telephone number (area code + the 7-digit telephone number).

Area Code Overlays - FYI ONLY as not in 217/447 region:

2009-Area Code 779 shares the same region as 815 Area Code

2023-Area Code 861 shares the same region as 309 Area Code

2023-Area Code 730 shares the same region as 618 Area Code



Long Distance Calling

NEW Area Code Overlay 217/447

The 447 area code was added as an overlay to the region currently served by area code 217 to ensure a continuing supply of telephone numbers for the area. An overlay is the addition of another area code (447) to the same geographic region served by an existing area code (217). Beginning March 27, 2021, new telephone lines or services may be assigned numbers using the new 447 area code.

Mandatory 10-digit Dialing

All local calls made within the Illinois 217/447 Area Codes must be placed using the 10-digit telephone number (area code + the 7-digit telephone number).

10-digit dialing does NOT affect three digit codes to reach 7-1-1 (Relay Services), 9-1-1 (Emergency Services) or any other community codes that may be available in your area.

NEW Way To Reach National Suicide Prevention Lifeline By Dialing 988

On July 16, 2020, the FCC adopted an Order (FCC 20-100) approving "988" as the 3-digit abbreviated dialing code to reach the National Suicide Prevention Lifeline, starting July 16, 2022.

Beginning July 16, 2022, dialing "988" will route your call to the National Suicide Prevention Lifeline.

Calling Within Your Local Calling Area

Effective 02/27/21 with Area Code Overlay 217/447, customers will now have to make local calls using 10-digit dialing (217/447 + 7 digit number).

As part of your local service, calls made within your exchange are toll-free. The box on Page 6 identifies additional toll-free calls as part of Extended Area Service (EAS).

Intralata Calling

Consolidated Communications customers may choose the company that handles their IntraLATA calls. IntraLATA calling is sometimes referred to as "regional calling."

IntraLATA calls are those calls outside of your local calling area to any place within a defined service area or "LATA" (local access and transport area). LATA MSA8 includes all or part of the following counties: Clark, Coles, Douglas, Edgar, Moultrie, Effingham, Shelby, Christian, Montgomery, Cumberland and Macoupin. (See LATA map on Page 8).

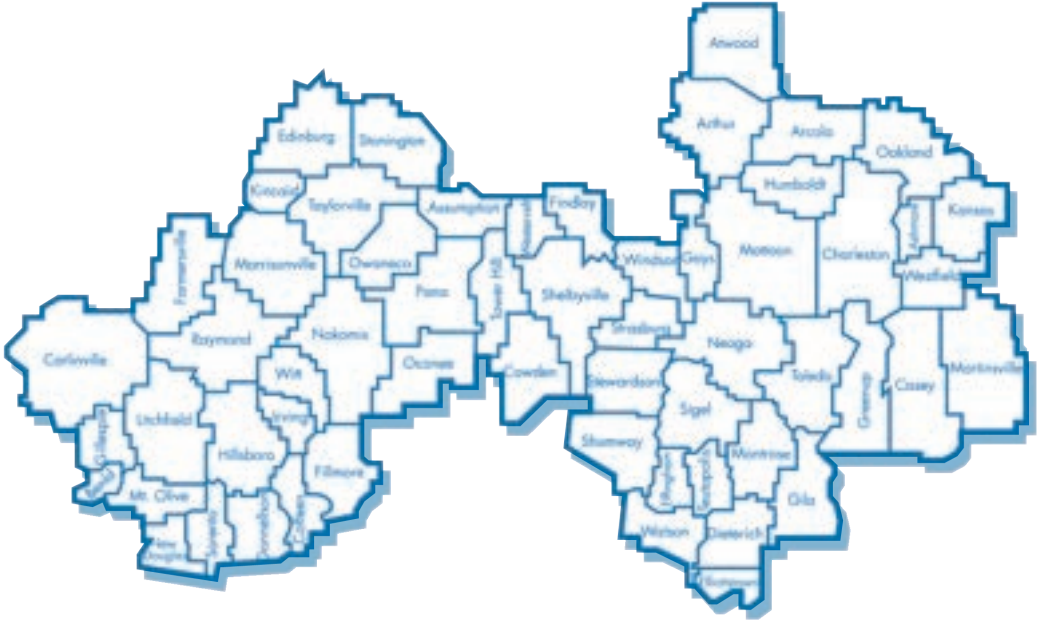
You have three options for handling your IntraLATA calls:

1. You may choose Consolidated Communications to handle your IntraLATA calls.
2. You may choose your current long distance company to handle your IntraLATA calls (if your current company provides IntraLATA service).
3. You may choose a different long distance company to handle your IntraLATA calls, (any company that provides IntraLATA service).

If you choose option #1, no action is required. Consolidated Communications will continue to handle your IntraLATA calls just as we do now. This way, you will continue to receive one phone bill for local service and regional calls, as you always have. If you choose options #2 or #3, you should contact your current long distance company or the company of your choice.

Long Distance Calling

Types Of Long Distance Calling

Station-To-Station

When calling direct from the Consolidated Communications service area dial Area Code + 7-Digit number for all local calls.

For numbers outside of the 217 and 447 area call:
1 + Area Code + 7-Digit number.

Dial-Direct, Station-to-Station calls are the least expensive type of calls. When you dial direct, without operator assistance, you are charged the lowest rate.

An Operator-Assisted, Station-to-Station call occurs when you will talk with anyone who answers but you need an Operator's assistance for any reason. Examples of such calls are coin, collect, calling card, third number, code billing (special billing numbers), time and charge and conference.

Person-To-Person

To call Person-to-Person, dial 0 + Area Code + 7-Digit number and give the name of the person you wish to talk to or the extension number.

Collect

Collect calls can be made only if the person or firm you are calling agrees to pay the charges. Within and outside of the 217 and 447 area, dial 0 + Area Code + 7-Digit number.

Long Distance Calling

Bill To Third Number

Within the 217/447 area, dial 0 + the phone number. Outside the 217/447 area, dial 0 + the area code + the phone number. When the operator comes on the line, give the area code, number and name the call is being charged to.

Coin

See the instruction card on or near the phone you are calling from or call the operator for assistance.

International

See Page 12 for instructions on placing International calls.

Operator-Assisted Charges

To cover the cost of operator handling, you pay additional charges for any long distance call requiring the assistance of an operator.

You Will Not Be Charged If...

You hang up before you complete the number, or if the telephone number you call is busy or does not answer.

If You Reach A Wrong Number

Within MSA8, call the operator immediately and explain what happened. The operator will make sure you aren't charged for the call. When calling outside MSA8, call your long distance operator by dialing "00." Locations within MSA8 are found on Page 8.

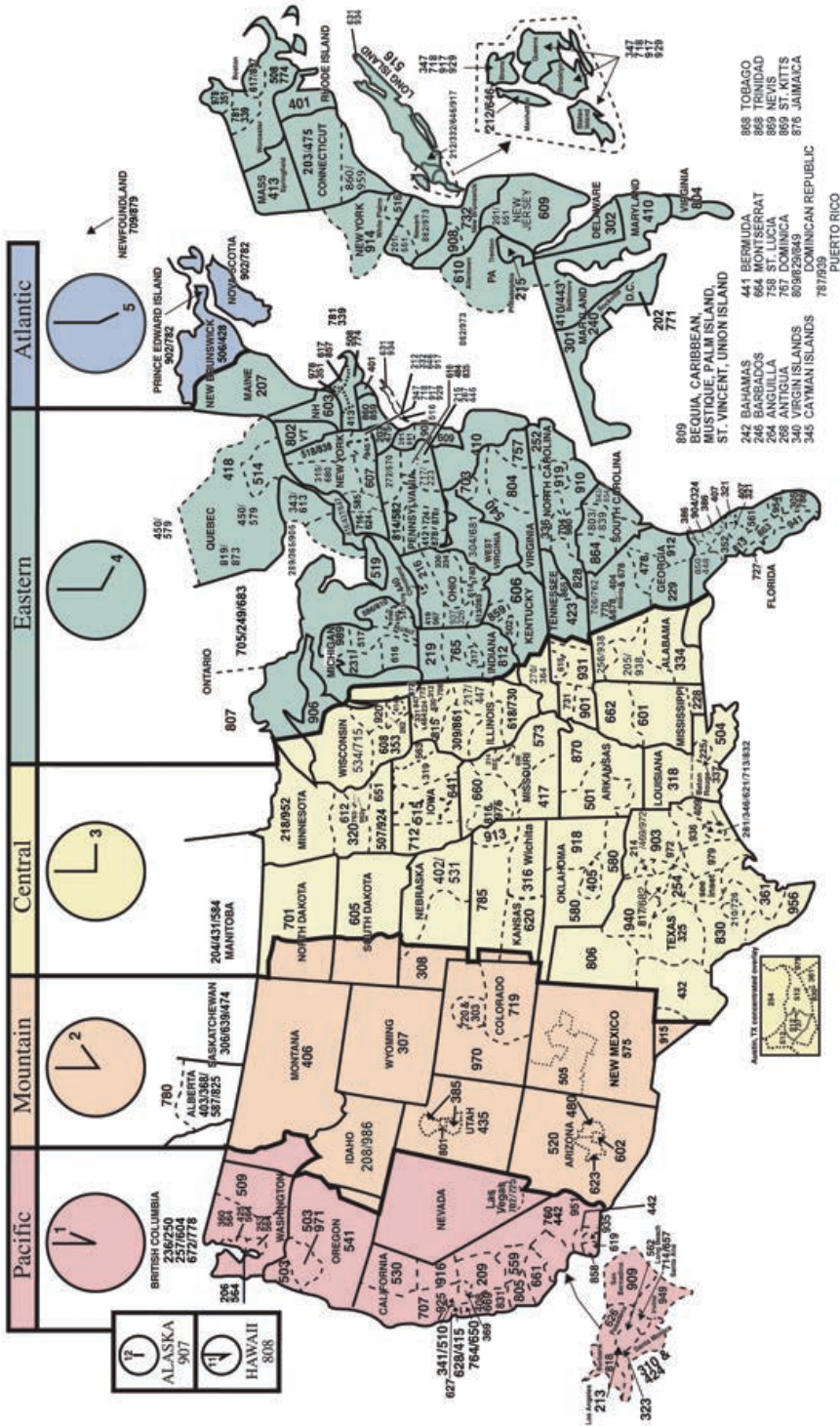

Do Not Call List

National Do Not Call Registry

To address consumer concerns about unwelcome telemarketing calls, the Federal Communications Commission (FCC) and Federal Trade Commission (FTC) have established a national Do Not Call Registry. The registry applies to all telemarketers (with the exception of certain nonprofit and political organizations) and covers both interstate and intrastate telemarketing calls. Commercial telemarketers are not allowed to call you if your number is listed on the registry.

There is no cost to register your phone number, and it will remain on the national Do Not Call Registry permanently. You may remove your name from the list at any time. The Do Not Call Registry will not prevent all unwanted calls. It does **not** cover:

- Calls from organizations with which you have established a business relationship.
- Calls that are not commercial and do not include unsolicited advertisements.
- Calls for which you have given prior written consent.
- Calls by or on behalf of tax-exempt organizations.

Illinois law adopts the National Do Not Call Registry, giving consumers the benefit of being included in both state and national registries with the convenience of free one-step enrollment. Consumers may register their residential telephone number, including wireless numbers, on the national Do Not Call Registry at no cost by telephone or on the Internet. Inclusion of your telephone number on the national Do Not Call Registry will be effective 31 days following your registration.

Special Assistance Program

Lifeline Program

Consolidated Communications offers a Lifeline Program for eligible low income residential subscribers at their primary residence. The Lifeline Program is a government benefit program.

Eligible subscribers can apply a monthly federal Lifeline Program discount to a voice service OR a qualifying Internet service. If applicable, there is a Federal Tribal Lifeline Program which provides additional discounts on local voice service OR a qualifying Internet service. In some states, an additional monthly voice discount is also available.

To qualify for Lifeline Program support, residential customers must receive benefits from qualified assistance programs. Alternatively, customers with household income meeting specific Federal Poverty Guidelines may also qualify for Lifeline Program support. Eligible subscribers who apply the Federal Lifeline Program discount to their voice service may also qualify for free toll blocking to help control long distance usage.

Only one Lifeline Program discount is available per household on either a wireless or wireline qualifying service. Under the Lifeline Program, a household is defined as any individual or group of individuals who live together at the same address and share income and expenses. The Lifeline Program benefit is non-transferable. Consumers who willfully make false statements in order to obtain the discount can be punished by fine or imprisonment or can be barred from the Lifeline Program.

About Your Phone Bill

If You Can't Pay Your Bill On Time

When you regularly pay your phone bill by the due date printed on the bill, you maintain good credit with us. Good credit entitles you to establish new service or add extra service without paying a deposit.

If you cannot pay your bill on time, call your Consolidated Communications Customer Service Representative and explain why. We may be able to help you. Otherwise, your phone service may be disconnected. To get service reconnected, you may have to pay all charges billed for service and an additional payment or security deposit for reconnecting your service. You are not charged for the first time you have service restored during a calendar year.

Help us provide you with continuous service by paying on time or telling us why you can't.

Customer Credit Notification

The law obligates all telecommunication carriers to provide installation and repair in a timely manner. Credits or other remedies may be available for delays in repair, installation or missed appointments.

These requirements include:

- Installing basic local exchange service within 5 business days after receipt of a complete order from a customer. If a customer requests an installation date that is beyond 5 business days, service must be installed by the customer-requested date.
- Restoring basic local exchange service within 24 hours of receiving proper notice that a customer's telephone service is out of service.
- Keeping all repair and installation appointments for basic local exchange service when the company informs the customer that a premise visit requires the customer to be present for the appointment, unless the telephone company provides 24 hours notice of its inability to keep the appointment.

If a delay in repair, installation or missed appointment occurs, credits will be automatically calculated and applied to the next month's bill*. Credits are identified on bill as "Service Quality Credit" or "S.Q. Credit." Credits are subject to certain limitations and exclusions.

Customers may not be entitled to a credit when:

- An emergency situation arises.
- A customer's willful or negligent act prevents the company from providing service.
- A customer's inside wiring or telephone equipment malfunctions.
- The customer misses an appointment or requests a later appointment.
- The company is unable to gain access to the customer's premises due to the customer missing an appointment.

- A customer violates one or more Commission rules and is refused service by the carrier.
- The company is lacking facilities at the service location.
- * These requirements are based on 83 Illinois Administrative Code 732. They are subject to change by the Illinois Commerce Commission.

Credit Calculations

In the event an automatic credit is required for out-of-service repairs, the credit calculation is based on:

Basic Service Repair	Credit (taxes not included)
Up to 29 Hours.....	\$5.00 credit
30-47 Hours	pro-rata the MRC for local services
48-72 Hours	33% of one month's recurring charges
72-96 Hours	67% of one month's recurring charges
96-120 Hours.....	100% of one month's recurring charges
Over 120 Hours	alternative telephone service or \$20 per day (at the customer's option)

For installation, the calculation of the automatic credit is based on:

Basic Service Installation	Credit Amount (taxes not included)
After 5 business days but less than 10 business days**	50% installations charges
More than 10 business days.....	100% installation charges
	alternative telephone service \$20 per day (at the customer's option)

** The different scenarios are applicable in the calculation of the credit. Installation credits vary for LinkUp customers.

If the local exchange telephone company misses an appointment without providing 24-hour notice to the customer a credit of \$50 will be issued.

About Your Phone Bill

Consumer Information

Although the phone is a wonderful communication tool, it sometimes can be abused. We think it's important for all our customers to be aware of their rights and responsibilities under the law.

Fraudulent Calls

It's illegal for another person to charge long distance calls to your number or your calling card without your permission. At Consolidated Communications, we take this very seriously. A Consolidated Communications fraud control team continually identifies, evaluates and implements fraud prevention measures to protect you. It is against state laws to defraud or attempt to defraud the phone company of its lawful charges. If convicted, violators are subject to imprisonment and/or a fine. Consolidated Communications is committed to preventing telecommunications fraud before it happens.

How To Prevent Phone Fraud When At Home...

- Never accept third-party or collect calls that are suspicious or from someone you do not know. When you accept, you have agreed to pay for the charges.
- Telephone companies or law enforcement officials will never ask customers to accept collect or third-party charges as part of an investigation. The only time a telephone company representative will request specific billing information is if you make a call through an operator.
- Restrict third-number or collect calls from being made to your home. Consolidated Communications offers this service at no charge to the consumer, thus preventing fraudulent calls from being billed to your line.
- If you do not make international calls or calls to the 809 area code, ask if a block is available for your exchange.

How To Prevent Phone Fraud In Your Car...

- Remove the handset and antenna from the car when it's not in use. This will help avoid the unwanted attention of criminals.
- Protect your Electronic Serial Number. Never give your ESN number to anyone. And don't put your subscriber agreement in an unsafe place, such as the glove compartment.
- Never let anyone else use your phone unless you are present. If someone wants to use your phone, offer to dial the number for them. Fraud criminals easily can access the codes stored in your phone.
- Have service performed only at reputable locations. If you need service, take your phone only to an authorized distributor of your cellular service.

- If your phone is stolen, call your local police and cellular carrier immediately. The sooner you do, the less likely your phone will be used fraudulently.

Don't Get Slammed

Some long distance carriers are engaging in the practice commonly known as "slamming" – switching consumers' long distance service without their knowledge or consent. This is an illegal practice and can be prevented. While Consolidated Communications may be able to help resolve the problem after it happens, we would rather protect you BEFORE it happens. If you would like to prevent your long distance service from being "slammed," you can do so at no charge by calling 1.844.968.7224 to ask for a PIC freeze.

Internet Usage

The Internet is one of the newest targets for fraudsters. Due to the rapid growth in this industry, increased consumer awareness is critical. If you are an Internet user, help protect yourself by following these tips:

- Use extreme caution when giving out financial or personal information such as credit card numbers, bank accounts and Social Security Numbers – and make sure the site is secure.
- Conduct business with companies you know and trust.
- Look carefully at information about products or services being offered. Ask for more information if needed. Always read the fine print.
- Check out the company's reputation. The Better Business Bureau is one agency that can help you.
- Use caution when downloading programs or services. This is a potential avenue for viruses.
- Ensure a local access number to avoid toll charges.

Protecting Your Privacy - CPNI Notice

In providing service to you Consolidated Communications collects information about your calling patterns and about the particular services you receive from us. This information may include the quantity, technical configuration, type, destination, location, and amount of use of the telecommunications services that you purchase. Information of this sort is known as Customer Proprietary Network Information, or CPNI. Protecting the privacy of your service and usage records is your right and our duty under state and federal law. We will not share your information outside of Consolidated Communications.

From time to time, we would like to offer you additional products or services that may be of interest to you and would like to share some of your CPNI across the Consolidated family of companies for marketing purposes and to offer these additional products or services to you. We are required to inform you that you can direct us not to use information about the services you have purchased from Consolidated Communications. If you do not want

us to use any of your service and usage information to offer you products and services, call your Consolidated Communications Customer Service Representative at 1.844.968.7224.

There is no charge for choosing to restrict the use of your information, and you may restrict it at any time. If you do not restrict our use of your customer information, we can use your customer information to offer you products and services that you may find valuable based on your existing services. Restricting your information will not affect the products and services you currently receive from Consolidated Communications and may not eliminate all marketing contacts. Even if you restrict use of your information, it may be used to market services to you when you call us. Your election is valid until you affirmatively revoke or limit it.

900 Numbers

900 numbers are not free. When calling a 900 number, you will be charged either a flat rate or a per-minute charge that could range from \$0.50 to several dollars per minute. The amount you are charged is determined by the provider of the 900 service.

If you think you've been incorrectly billed for a 900 call, you have 60 days after receiving a bill to request an investigation of the charges. During the investigation, you have the right to withhold payment for the disputed charges. No collection activity will be brought against you for those charges during this period. (If the charges are found to be legitimate, the long distance carrier or information provider may start a collection process against you).

Your local and long distance service cannot be disconnected if you fail to pay 900 charges. Your long distance company may block your access to 900 numbers if you do not pay legitimate charges. You should not be billed for 900 pay-per-call services that do not comply with federal laws and regulations. In most exchanges, you can ask Consolidated Communications to block access to 900 numbers from your phone. With 900 number blocking, no one will be able to call a 900 number from your home or business phone. Your long distance service will not be affected, and you will still be able to call toll-free numbers.

Identity Theft

What is identity theft and how does it occur? Identity thieves steal personal information with the intent to commit an unlawful act. Identity theft often occurs without victims being aware of the illegal activity until they review a credit report and find errors, make a major purchase such as a car or are contacted by a collections agency for payment of debts of which the victim has no knowledge.

Thieves may go through trash looking for personal data such as pre-approved credit card applications, old bank statements or other personal data.

Therefore, it is a good idea to shred any documents containing personal information before they are discarded. If your mail is delivered to a place where others have access to it, thieves may intercept it. Because identity theft commonly includes misuse of a Social Security Number (SSN), it is a good idea to ask that an alternative source of identification be used when your SSN is requested.

Put simply, it is important to be careful when you share any kind of personal information on the phone, in person, on paper or over the Internet.

If you become a victim of identity theft, contact the Federal Trade Commission at 1.877.ID.THEFT (1.877.438.4338) to place a nationwide alert on all of your accounts. Next, notify the financial institutions where your accounts may have been tampered with. Closing of these accounts may be required. Place a watch on all checks coming through your account to ensure only checks you wrote are paid. Change your ATM card and PIN number. You may want to contact Telecheck, a nationwide company capable of sending an alert to all merchants not to accept any checks from your account until the fraud case is resolved. In addition, contact all of your credit card companies.

Follow up all of your phone calls with a letter. The letter clearly should identify any items in your statement(s) that you dispute. Explain in detail why the information is disputed and request deletion or correction. Enclose a copy of the police report you filed as well.

Prevention Tips

To review, it is always advisable to limit the amount of personally identifying information you reveal to anyone. Pay attention to your billing cycles and follow up with creditors if your bills do not arrive on time. Guard your mail. Deposit all outgoing mail at the post office or a collection box. Shred all credit card applications and other documents containing personal information. If possible, place passwords on all of your financial accounts. Do not share these passwords with anyone. Do not carry your Social Security card in your purse or wallet or place your SSN on your checks. Check your credit report annually with each of the major credit bureaus to ensure your report is accurate. Report all lost or stolen bankcards and credit cards immediately to your financial institutions. Carry only the cards and identification you need.

Harassing Calls

Illinois law defines harassment by telephone as the use of telephone communication for any of the following purposes:

- Making lewd or indecent comments or requests with intent to offend.
- Making one or repeated telephone calls, whether or not conversation occurs, with intent to abuse, threaten, or harass.

Your Rights As A Customer

- Causing the telephone of another to ring repeatedly with intent to harass.
- Knowingly allowing any telephone under one's control to be used for any of the above.

If you receive obscene, harassing or threatening calls:

- Hang up if caller uses obscene language or doesn't say anything the second time you say hello.
- Don't give out information like your name or address until you find out who is calling.
- Tell your children and guests not to give out any information to strangers. If you're not home, they should say, "They can't come to the phone right now. May I take a message?"
- If the calls persist, call your Consolidated Communications Customer Service Representative at 1.844.968.7224.

Caller ID Block

As a Consolidated Communications customer, you can determine on a call-by-call basis whether or not someone with Caller ID sees your number or name. If you do not want your number delivered, simply dial *67 (or dial 1167 from a rotary phone) before dialing the number. Once you hang up, your number again will be delivered to those with Caller ID service until you dial *67 again before a specific number.

Caller ID Block automatically is provided free of charge to Consolidated Communications customers where Caller ID services are available. Note: It is possible that when you call toll free numbers, your number still will be displayed. When dialing 911, emergency calls, your number ALWAYS will be displayed.

Unlawful Wiretapping

Wiretapping or any interception of a phone call without prior consent is a crime under both federal and state laws. Federal law requires consent of one of the persons involved in the call, and Illinois law requires the consent of everyone involved. Properly authorized federal agents may intercept a call without consent only with an appropriate court order. Penalties for illegal wiretapping can be imprisonment and/or a fine.

Recording Phone Conversations

It's against both federal and state regulations to record a phone conversation without the other person's knowledge. Recording of two-way conversations must feature a warning "beep" tone at 15-second intervals. If you hear this tone and don't want a record of what you're saying, ask the person you've been talking with to disconnect the recording machine. If you wish to record a conversation, your recording equipment must have a "beep" tone and meet registration requirements of the FCC. Use of a recorder without the "beep" tones is permitted only in the case of emergency by fire, police and other emergency-service agencies.

Phone Receiver Off The Hook

At times, you may not wish to receive incoming calls. Please don't leave the receiver off the hook, because this unnecessarily congests the switching equipment. In some cases, we may have to disconnect your line to avoid overloading the equipment. When this happens, your phone will not work until it is reconnected in our switching office. If your phone is equipped with a jack, simply unplug it instead.

Consolidated Communications Employee Identification Cards

For your protection, any employee who visits customer premises carries an official identification card showing his or her name and photograph. If you have the slightest doubt about anyone who says they're "from the telephone company," ask to see their identification card.

Telephone Safety

The telephone is one of the safest appliances in your home or office. There are, however, a few situations where a telephone user needs to be cautious.

Using A Phone Near Water

The telephone should not be used while you are in a bathtub, shower or pool. Immersion of the telephone or handset in water could cause an electrical shock.

Using A Phone During Electrical Storms

Only make calls of an urgent nature, and keep them brief. Although our telephone systems uses protective measures to limit abnormal electrical surges from entering your home, there is a remote risk of a dangerous electrical shock from lightning when using the telephone during a nearby electrical storm.

To Report A Gas Leak

If you think you've found a gas leak, you shouldn't use a phone in the vicinity of the leak until the leak is repaired. The telephone contains electrical contacts that could generate a tiny spark when you lift the handset and dial. While unlikely, it may be possible for this spark to trigger an explosion if the gas concentration is high enough.

Your Rights As A Customer

Attachments

Attachments connected to Consolidated Communications lines must be in compliance with company tariffs and FCC regulations.

About Your Phone Number

Your telephone number is the property of Consolidated Communications. We may change your number if it becomes necessary in order to provide improved service to the community. If you do business with a telecommunications company that has arranged for Consolidated Communications to do its billing, we are required to share your name, address and telephone number (including non-published numbers) with that company. They may use the information only for accounting and billing purposes.

Stopping Phone Service When You're Out Of Town

If you wish to stop your telephone service, call your customer service representative. There is no charge for disconnection, and charges to your bill can be stopped the day you call. As an alternative, for an additional charge you can have your telephone service temporarily suspended (for example, when you're going on vacation). Service can be restored on short notice when you return.

If You Have A Complaint

If you have a complaint about any aspect of service you receive from Consolidated Communications, call your customer service representative at 1.844.968.7224. He or she will answer your questions and make every effort to resolve your problems.

If you are not satisfied with the help you receive from a customer service representative, ask for a manager. If your complaint is about credit, billing, deposits or termination of service, you can set up a personal meeting with a Consolidated Communications representative whose job it is to resolve those disputes.

If you don't resolve the dispute with the representative, you can file an informal complaint with the Illinois Commerce Commission. The ICC is the state agency that regulates Consolidated Communications and other public utilities in the state. The address and phone number is:
