Public Notice of Copper Retirement Under Rule 51.333

Pursuant to Section 51.327(a) of the Commission's rules, 47 C.F.R. § 51.327(a), Consolidated Communications of Minnesota Company ("Consolidated Communications") provides the following information:

Implementation Date:

The Minnesota Department of Transportation ("Minnesota DOT") has given Consolidated Communications a deadline of **May 15, 2025** to discontinue all use of its copper loop plant that will be destroyed by road work to be performed along a two-mile section of TH-60, between County State Aid Highway ("CSAH") 20, on the west, and County Road 112, on the east, in Lake Crystal, Minnesota. This work will necessitate the removal or disabling of approximately 20,000 feet of underground copper loop plant, resulting in a "copper retirement" as defined under the Commission's rules, 47 C.F.R. § 51.325(a)(3).

The Minnesota DOT's planned road work constitutes a circumstance outside of the control of Consolidated Communications. Pursuant to Section 51.333(g)(2) of the Commission's rules, 47 C.F.R. § 51.333(g)(2), Consolidated Communications cannot comply with the 90-day notice requirement prescribed in Section 51.333(b)(2) of the Commission's rules, 47 C.F.R. § 51.333(b)(2), and is hereby providing notice of the network change as soon as practicable. The required Public Notice waiting period should therefore be reduced accordingly.

Consolidated Communications is making a separate Section 63.71 service discontinuance filing reflecting the impact of this road work, contemporaneously herewith, and has notified all affected customers of the change in connection with that filing.

Location of the Planned Network Changes:

Road work will take place along a two-mile section of TH-60, between CSAH 20, on the west, and County Road 112, on the east, in Lake Crystal, Minnesota. The work will result in the loss of copper loop facilities to approximately 81 serviceable addresses within the service area of

Consolidated Communications, including approximately four with active service. The affected addresses, all of which are already served by fiber, are provided in Attachment 1.

Description of the Planned Changes:

Copper loop plant must be removed along the affected route. Consolidated Communications has deployed fiber optic facilities that enable higher speed, scalable broadband services to all addresses in this area. It is not feasible to install the cabinet nodes and optical-electrical network equipment that would be necessary in order to continue using the remaining portion of the old copper loop plant.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Copper-based voice and digital subscriber line services will no longer be available at any of the affected locations. As a replacement, Consolidated Communications will utilize existing fiber facilities to offer VoIP service, both as part of broadband service package and on a standalone basis. In addition, mobile voice and broadband services are available throughout the affected area from multiple wireless service providers, including at a minimum from AT&T, Verizon, and T-Mobile. Mediacom also offers wireless voice and data services in the affected area under the "Xtream" brand, both on a standalone basis and bundled with its fixed broadband fiber offerings.¹

Consolidated Communications does not anticipate that this work will impact any competing service provider's performance or ability to provide service, nor its interoperability with other service providers. No CLEC purchases unbundled copper loops or other wholesale services that will be affected by this work. There are no other telephone exchange service providers that directly interconnect with the Consolidated Communications network, *see* 47 C.F.R. § 51.333(a).
