## **Roseville 5E Retirement**

The Consolidated Communications of California (OCN 2334) Roseville 5E Switch RSVLCAXF78G and RSVLCAXF04T, located at 224 Lincoln St, Roseville, CA 95678, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of California Roseville T7000 RSVLCAXFPS1 located at 224 Lincoln St, Roseville, CA 95678. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic.

#### **Citrus Heights 5E Retirement**

The Consolidated Communications of California (OCN 2334) Citrus Heights 5E Switch CTHTCAXF72G, located at 7656 Old Auburn Rd, Citrus Heights, CA 95610, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of California Citrus Heights POI CTHTCAXF0MD located at 7656 Old Auburn Rd, Citrus Heights, CA 95610. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic.

## **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

## **Roseville 5E Retirement**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Roseville 5E to reflect the move to the Roseville T7000 RSVLCAXFPS1. Carriers that are code holders for access connectivity in the Roseville 5E Switch will be required to reposition the codes to the Roseville T7000 RSVLCAXFPS1.

## Citrus Heights 5E Retirement

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Citrus Heights 5E to reflect trunking to the Citrus Heights POI CTHTCAXF0MD. Carriers that are code holders for access connectivity in the Citrus Heights 5E Switch will be required to reposition the codes to the Roseville T7000 RSVLCAXFPS1.

ASRs for the Roseville T7000 must be received in order to make changes to records. All traffic for these trunk groups will be migrated to the Roseville T7000. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Citrus Heights 5E Switch (on or after 01/30/2024). This will serve as a guide for interconnecting companies to update their records reflecting the new CLLI and switch type.
