Pursuant to Sections 51.325-51.335 of the Commission's rules, Consolidated Communications of Texas submits the attached Short Term Public Notice and Certification of Short Term Public Notice under rule 51.333(a). Specifically, Consolidated Communications of Texas is providing notification of the network changes that result in the decommissioning of the Consolidated Communications of Texas Lufkin (LFKNTXXADS0 and LFKNTXXA02T) switch and replacing it with a T7000 Switch (LFKNTXXAPS2 and LFKNTXXAG0T) located at 321 N 1st St, Lufkin TX 75901. **Implementation Date: On or after January 30, 2024**

**Description of the Planned Network Change(s):**

The Consolidated Communications of Texas (OCN 2109) Lufkin DMS Switch LFKNTXXADS0 and LFKNTXXA02T, located at 321 N 1st St, Lufkin TX 75901, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of Texas Lufkin T7000 LFKNTXXAPS2 located at 321 N 1st St, Lufkin TX 75901. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic.

**Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Lufkin DMS to reflect the move to the Lufkin T7000 LFKNTXXAPS2. Carriers that are code holders for access connectivity in the Lufkin DMS Switch will be required to reposition the codes to the Lufkin T7000 LFKNTXXAPS2.

ASRs for the Lufkin T7000 must be received in order to make changes to records. All traffic for these trunk groups will be migrated to the Lufkin T7000. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Lufkin DMS Switch (on or after 01/30/2024). This will serve as a guide for interconnecting companies to update their records reflecting the new CLLI and switch type.
