Specifically, Consolidated Communications of Illinois is providing notification of the network changes that result in the decommissioning of the Consolidated Communications of Illinois Charleston (CHTNILXCDS0) and Taylorville Switches (TYVLILXCDS0) and replacing it with a T7000 Switch (MTONILXCPS0 and MTONILXCG0T) located at 1501 CHARLESTON AVE, MATTOON, IL 61938. The Consolidated Communications of Illinois (OCN 1037) Charleston DMS Switch CHTNILXCDS0, located at 805 7TH ST, CHARLESTON, IL 61920, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of Illinois Charleston, IL POI CHTNILXC2MD located at 805 7TH ST, CHARLESTON, IL 61920. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic. This is a rolling migration and CCI will be keeping up both switch and/or tandem connections until all the CCI customers have been migrated from the old switch.

### **Taylorville DMS Switch Retirement**

The Consolidated Communications of Illinois (OCN 1037) Taylorville DMS Switch TYVLILXCDS0, located at 216 N WEBSTER ST, TAYLORVILLE IL 62568, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of Illinois Mattoon Taylorville, IL POI TYVLILXCX0X located at 216 N WEBSTER ST, TAYLORVILLE IL 62568. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic. This is a rolling migration and CCI will be keeping up both switch and/or tandem connections until all the CCI customers have been migrated from the old switch.

#### Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

## **Charleston DMS Switch Retirement**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Charleston DMS to reflect the move to the Charleston, IL POI CHTNILXC2MD. Carriers that are code holders for access connectivity in the Charleston DMS Switch will be required to reposition the codes to the Mattoon T7000 MTONILXCPS0.

#### **Taylorville DMS Switch Retirement**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Taylorville DMS to reflect trunking to the Taylorville, IL POI TYVLILXCX0X. Carriers that are code holders for access connectivity in the Taylorville DMS Switch will be required to reposition the codes to the Mattoon T7000 MTONILXCPS0.

ASRs for the Mattoon T7000 must be received in order to make changes to records. All traffic for these trunk groups will be migrated to the Mattoon T7000. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Charleston and Taylorville DMS Switches (on or after 08/01/2024). This will serve as a guide for interconnecting companies to update their records reflecting the new CLLI and switch type.
