Specifically, Consolidated Communications of Pennsylvania is providing notification of the network changes that result in the decommissioning of the Consolidated Communications of Pennsylvania Wexford DMS Switch (WXFRPAXWDS0) and replacing it with a T7000 Switch (GIBSPAXGG0T) located at 4008 GIBSONIA RD, GIBSONIA, PA 15044. Description of the Planned Network Change(s):

The Consolidated Communications of Pennsylvania (OCN 1093) Wexford DMS Switch (WXFRPAXWDS0), located at 150 WEXFORD BAYNE RD, WEXFORD, PA 15090, will be retired and removed from the network after all traffic served by this switch is migrated to the Consolidated Communications of Pennsylvania Wexford, PA POI WXFRPAXW0MD located at 150 WEXFORD BAYNE RD, WEXFORD, PA 15090. All traffic to be migrated includes but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), Intra-LATA, Local, wireless, and paging traffic. This is a rolling

migration and CCI will be keeping up both switch and/or tandem connections until all the CCI customers have been migrated from the old switch.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to update records of trunk groups currently terminating to the Wexford DMS to reflect the move to the Wexford, PA POI WXFRPAXW0MD. Carriers that are code holders for access connectivity in the Wexford DMS Switch will be required to reposition the codes to the Gibsonia T7000 GIBSPAXGPS0.

ASRs for the Gibsonia T7000 must be received in order to make changes to records. All traffic for these trunk groups will be migrated to the Gibsonia T7000. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Wexford DMS Switch (on or after 08/01/2024). This will serve as a guide for interconnecting companies to update their records reflecting the new CLLI and switch type.
