

Fidium Fiber LNP Changes to support Simple Port Orders

1. Number Port Requests May Be Simple or Non-Simple

1.1. Simple Ports

Requests which meet the criteria for Simple Porting, listed below, will be evaluated against a much smaller set of validations and business rules, and may be submitted with a Desired Due Date (DDD) as short as 1-2 business days from the recognized date of the request. However, a 1-2 business day DDD is not required for a request to be classified as a Simple Port. Further, a Simple Port request is not prohibited from containing more than the 14 fields addressed in the FCC rulings and industry recommendations. However, if additional fields, which are optional for Simple Ports, are populated in the request, they are subject to existing validation and business rules for Number Ports.

1.2. Non-Simple Ports

Requests which do not meet the criteria for Simple Porting will be treated as a Non-Simple Port and the current validations and business rules for Number Ports will apply.

2. Eligibility and Recognition of Simple Port Requests

All Number Port requests, including Supplements, which are identified by Request Type (REQTYP) "CB" and Activity (ACT) "V," will be evaluated for eligibility for Simple Porting upon receipt. REQTYP "BB" orders will not be evaluated, as they do not meet the eligibility criteria for Simple Port. As described in FCC rulings and industry best practices, the criteria for eligibility for Simple Port treatment are as follows:

- a) The port request is for a single telephone number, which is the only telephone number on the account.
- b) The port does not involve unbundled network elements.
- c) The port does not include complex switch translations
- d) The port does not include a reseller.
- e) The port does not include changes to directory listings.



The only treatment allowed of directory listings for a Simple Port will be to retain or not retain the listings. Inclusion of a DL form in the request will cause the request to be ineligible for Simple Port treatment.

3. Fidium Fiber Implementation of the 14 Fields Which May Be Required for Simple Porting

The following table summarizes how Fidium will implement the 14 fields that may be required for Simple Ports, identified in the FCC ruling and OBF recommendation.

Additionally, Fidium Fiber will apply the following criteria to Simple Port orders:

- Directory Listing (DL) changes will not be supported for Simple Ports. The Customer may choose to retain or remove listings currently associated with the TN being ported. The only values that Fidium will accept for Simple Ports in the ELT field are "A" or "B", if ELT is populated.
- 2) If ELT is not populated, the order will be processed with the default of "B" (do not retain listing). Submitting a Number Port order where ELT = "E" or "P" will make that order ineligible for treatment as a Simple Port.
- 3) Next Business Day due dates for Simple Port orders will be accepted until 1:00 PM. Orders received after 1:00 PM will be treated as being received the following business day, with the earliest due date being two business days following that order received after 1:00 PM.

A Number Port order (REQTYP = "CB", ACT = "V") that contains a due date (DDD) which is less than the standard interval (3 business days) and does not qualify as a Simple Port will be rejected, with the following error message:

"The due date you have entered is not available. The first available date is {next available due date}. Please supplement your order and provide a date equal to or greater than this date."

4. Supplements

4.1. Simple or Non-Simple Classification of Orders are Allowed to Change in Supplements

Fidium will allow and recognize Supplemental Orders which change an order to or from a Simple Port request. An order that is submitted as a Non-Simple Port request may be changed to a Simple Port request, and a Simple Port may become a Non-Simple Port request in a supplement. Every Number Port request, whether it is an original or supplement, is evaluated for Simple Port eligibility.



5. Fidium Field Requirement Impact for Simple Porting

The following table summarizes how Fidium' field requirement will be impacted by implementation of Simple Porting. The table includes all LSOG 9 fields and indicates the existing field requirement and the new requirement, which will apply to Simple and Non-Simple Porting, as well as listing new business rules associated with the new field requirement.

The net result of the field changes made to support Simple Porting is that the following 14 fields will now be optional for a Number Port order (REQTYP = "CB", ACT = "V"):

- 1. LOCQTY
- 2. D/TSENT
- 3. INIT
- 4. TEL NO (INIT)
- 5. LOCNUM (EU form)
- 6. STATE (EU form)
- 7. ZIP (EU form)
- 8. ELT
- 9. EATN
- 10. NPQTY
- 11. LOCNUM (NP form)
- 12. LNUM (NP form)
- 13. LNA (NP form)
- 14. NPT (NP form)

This means that no system changes are actually required by our customers to submit a Simple Port. If a Number Port order (REQ TYP = "CB") is placed that qualifies for Simple Port, it will still be successful if it is populated in the same manner as a successful Number Port order is populated today. It should also be noted that existing validations and conditional rules for optional fields still apply, if a customer chooses to include them in an order.



The 14 Simple Port fields referenced by the FCC and LNP Working Group are highlighted in yellow below. Changes to existing field requirements and rules for Number Port orders are highlighted in blue.
